What percentage of your current Year 6 cohort can swim competently, confidently and proficiently over a distance of at least 25 meters?	92%	
What percentage of your current Year 6 cohort can use a range of strokes effectively [for example, front crawl, backstroke, and breaststroke]?	92%	
What percentage of your current Year 6 cohort are able to perform safe self-rescue in different water-based situations?	100%	Although one of the children could not sustain 25 meters and a range of strokes, they were able to get themselves safely from the middle of the pool to the safety of the side and then climb out. We value this highly due to our proximity to the River Thames and multiple gravel pit lakes.
